




Key impacts of Brexit – March 2018

- Exchange rate & knock on effect
- European labour shortage



Sterling to Euro exchange rate



Exchange rate knock on effects

- Energy dense material / supplies
- High transport cost materials / supplies
- Foreign materials or supplies (not just European)
- Reduced labour supply Sterling worth less to foreign workers



Brexit conclusion

- Inflationary pressure ongoing (potentially until Brexit concluded)
- Inadequate inflationary allowance Project risk
- BCIS not working well too historic
- Carefully look at cost pressures on packages


